Sir/Madam,

In pursuance of Council's letter No.F.No.GAC-21-32/2017-CDN.dated 30th August ,2017 and FNo.FIN/10/02/2017-Pension dated 31st August,2017,the competent Authority / Council has extended the pensionary benefits of 7th pay commission to ICAR –CPCRI Pensioners/Family pensioners in respect of pre-2016 pensioners/family pensioners w.e.f 01/01/2016. The revised pension is to be made by multiplying with 2.57 with existing Basic Pension drawing by the pensioner. Hence, necessary arrangements may please made for revision of pension w.e.f 01/01/2016.

It is further instructed the bank not to pay the arrears from 01/01/2016 to 31/07/2017 until further orders. Revised pension may be paid from 01/08/2017 only.

Regarding revision of pension/family pension in respect of employees retired after 01/01/2016, revised PPOs will be issued for all and accordingly the pension may be paid from August 2017 onwards. No arrears are to be paid until further order.

Separate orders will be issued by this office for payment of arrears on account of revision of pension/family pension for the period of 1st January 2016 to 31st July 2017.

Further. O.M No.38/37/2016-P&PW(A) dated 04/08/2016. No.38/37/2016-P&PW(A) dated 12/05/2017 may be referred for any clarification.

Note: Dearness relief as sanctioned by the Govt. of India from time to time is payable to the pensioner with effect from date of sanction.
