PROCEEDINGS OF THE PENSION ADALAT AND MONTHLY MEETING
WITH PENSIONERS/FAMILY PENSIONERS UNDER PENSION
AUTHORIZING UNIT- 9 HELD ON 28.01.2020 AT ICAR-CPCRI RC, KIDU

Sri M. Ravindran, Asst. Administrative Officer, CPCRI RC, Kidu welcomed the gathering. Dr. K.S Ananda, Ex-Scientist-in-charge, CPCRI Research Centre, Kidu in his presidential address appreciated conduct of such meetings with the pensioners/family pensioners even at such a remote area like Kidu. Sri Ram Avtar Parashar, Senior Finance and Accounts Officer reviewed action taken on the decision of the last meeting held on 21.11.2019 at ICAR-IISR, Kozhikode and also briefed the importance of holding such meetings with Pensioners and Family Pensioners.

1. It was grieved by Sri A. Vishwanatha Rai, Retd. Technical Officer (Vehicle) that due to language problem and lack of knowledge most of the pensioners are not aware of their eligible pensionary benefits even for raising any grievances. After a detailed discussion, the SFAO advised the Asst. Administrative Officer, CPCRI RC, Kidu to confirm that, all the pensioners are being paid their eligible pensionary benefits including revision of pension, time to time.

2. Sri N. Nagesha, Ex-Technical Officer (F/F) grievanced that his GSLIS claim received was incomplete due to transfer of administrative control of CPCRI RC, Kidu from CPCRI RS, Vittal to Kasaragod headquarters and he requested to look in to the matter. On discussion it was came to the knowledge of the house that, since GSLIS is maintained in centralized system under a unique policy number, there will not be any break in the premium remittance and hence he has got his claim. However, it is advised to confirm from the relevant authority.

3. Some pensioners grievanced that, their pension was not revised as per VII CPC. It was informed that, all the proposals on revision of pension received from CPCRI RC, Kidu have been settled and it was requested to confirm that, all the pending cases have been sent to headquarters within a month.

4. Sri R. Kushalappa Gowda, Pensioner grievanced that, deductions on account of CVP is being recovered @ Rs.2024/- instead of Rs.1200/-. It was informed that, possibility of payment of revised CVP due to hike of pay and allowances. It was assured that, his case will be scrutinized and settled within few days. He has been informed vide letter dated 14.02.2020, that the deduction on account of Commuted Value of Pension is correct.

4. On discussion it was found that, the pension revision in respect of Smt. Chandravathi, W/o Sri Venkappa has to be reviewed.

5. The pensioners/family pensioners requested for early issue of Pensioners Identity Card. It was informed that, action is being taken in the Stores section of CPCRI Headquarters and it was advised the AAO, CPCRI RC, Kidu to confirm that, details of all the pensioners have been furnished to the headquarters for early issue of Identity Cards.
