The proforma when received back from the individual may be got reported/reviewed/remarks recorded by the Officer as indicated in Col. 7 of the attached statement with due regard to the guidelines contained in the ICAR letters No.F.18(1)/2004-Estt.IV dated 26<sup>th</sup> December, 2005 and 11<sup>th</sup> June, 2010. (CPCRI, Kasaragod Endt.No.F.4(10)3/2002-Estt.I dated 25<sup>th</sup> January, 2006 and 4(10)3/2007-Estt. Dated 07.07.2010 respectively.
